WHY do we need OFS?

Agriculture and forestry are Oregon's leading industries after high-tech manufacturing –

OFS represents well over 450,000 jobs in Oregon

- Agriculture
 - Over 9% of Oregon's economy; \$42 billion
 - More than 240 crops, many are #1 US crops
- Forestry and wood products
 - \$18 billion output; 3.8 billion board feet
 - #1 in the U.S. for softwood lumber and plywood, leader in engineered wood
- Golf
 - \$1.6 billion industry in Oregon



HB 4077: Environmental Justice - passed

HB 4002: Ag overtime - passed

HB 4141: Petroleum diesel phase-out - *failed*

SB 1534: Carbon sequestration - *failed*

SB 1532: Organic Extension positions - failed

Coalition Bills:

SB 1501, 1502: Private Forest Accord - passed


HB 4055: Forest products harvest tax - **passed**

Elections Update cont'd

30 Senators total, Democrats control Senate 17-13

- New Senate President, Rob Wagner (D-Lake Oswego, Tualatin, West Linn)
- New Senate Majority Leader, Kate Lieber (D-Beaverton, SW Portland)
- Republicans yet to elect leader, likely to continue to be Tim Knopp (R-Redmond, Bend)

60 Representatives total, Democrats control House 34-26

- Dan Rayfield (D-Corvallis) will remain Speaker, started in early 2022
- Julie Fahey (D-West Eugene, Lane County) remains as House Majority Leader
- Republicans also yet to elect leader, current leader is Vikki Breese Iverson (R-Prineville)

22 Legislators new to the Assembly

- 21 new House members
- 4 new Senators, 3 are former House members, 1 is new

January – June, 2023

Ongoing Regulatory Issues

ODA

- Crossbow petition
- · Soil amendment labeling
- · Handling of drift complaints and chronic complainers
- Pesticide registration fee increase
- Pesticide Stewardship Partnership

OR DEQ

- Pesticide General Permit
- Groundwater/nutrient strategy
- Amicus brief
- Recycling Program Rulemaking

ODF

• E-notification for aerial applications – SB 1602

US EPA

- · Revocation of food tolerances for chlorpyrifos
- Comments on registration reviews, petitions
 - Treated seed exemption; organophosphate ban





Other Issues

• Lincoln County aerial spray ban

- Case closed this year!
- Measure IP-3
 - Would ban killing of animals before natural life (hunting, fishing, pest control, some breeding practices all criminal acts)
- OSHA rulemakings
 - COVID-19, wildfire smoke, heat protections
- People not Politicians
 - Independent redistricting


